ORDER 1 Frieda Choudhury, a doctor of internal medicine, filed this action against her former employer, the Norris & Dunn Memory Hospital, for breach of contract and for breach of an employment agreement in violation of public policy. The district court dismissed Choudhury's breach of contract claim, and in an unpublished order, we affirmed. However, the court permitted Choudhury's claim for breach of the employment agreement in violation of public policy to go forward. At the close of discovery, the defendant moved for summary judgment. The court granted defendant's motion and entered judgment in its favor. Choudhury now appeals the judgment of the court. 2 Choudhury's cause of action is for violation of the Illinois Wage Payment and Collection Act. She claims that the hospital owed her wages due under an employment agreement that she signed when she was employed at the hospital. The alleged agreement promised her a salary of \$66,000 per year, plus overtime and benefits. 3 The district court determined that, although Choudhury had complied with the statutory preconditions to recovery of wages and penalties, she had failed to produce any evidence that a contract existed between herself and the hospital. In making this determination, the court concluded that Choudhury's statements in her answers to interrogatories were inconsistent with her assertion that she had a contract. For example, she claimed that the hospital had sent her a letter dated November 16, 1986, not January 27, 1988. She also said
